If the Buyer decides he/she is unable to keep said canine then the seller must approve of dogs new home or said canine must be returned to seller and buyer forfeits payment.

If canine is Breeding/Show Quality, the Buyer must have hips certified with the Orthopedic Foundation for Animals and eyes cleared by a Canine Ophthalmologist. Females are not to be bred before two years of age. Males are not to be bred before 18 months of age, and only after they have had hips and eyes cleared. If Buyer is breeding said canine (male or female) you will not breed to another dog unless their hips are rated fair or better and eyes are cleared within a year. If you breed said dog before the age and/or clearances the contract or contracts that are made with Four Seasons Kennels are null and void.

If canine is Pet/Companion Quality the buyer agrees to spay/neuter canine between six and eight months of age.

Guarantee

The following are the terms of the contract guarantee for canine, if being purchased as a Breed or Show Quality puppy. The Seller hereby guarantees that said canine will be free of the following for a minimum period of 26 months:

- A. Canine hip Dysplasia: An official qualified Veterinary report and X-ray is required for puppy replacement.

- B. Hereditary Eye Defects: If said canine should be diagnosed as having a debilitation eye defect, a report from a qualified canine Ophthalmologist will be required for replacement.
- C. Testicles: All males sold for breeding purposes shall be free from all monorchidism and cryptocidism. An official qualified Veterinary report is required for replacement.

Said canine is guaranteed to be physically healthy, free of any debilitating diseases for a period of 72 hours after purchase. This 72 hours begins when the purchaser picks up the canine from the seller or airport (provide shipping confirmation). We cannot guarantee the health of a new puppy beyond 72 hours because of exposure to health hazards, injury, disease, parasite agents, trauma, abuse, neglect and improper management – which are all out of the breeder's control.

The Seller of said canine is not responsible for any Vet bills of any type or any refunds for Vet bills. The Buyer has 72 hours from the time they receive the puppy to have the puppy's health checked by a Veterinarian. Replacement or refund of the purchase price requires a certificate from Buyer's Veterinarian sent by registered mail. The Seller's Veterinarian must confirm diagnosis.

If a puppy back, breeding back, or litter pick is part of the sale price of said canine, the Buyer agrees that the value of said canine breeding or litter pick is \$ _____. Should said canine die before the seller obtains said canine, breeding, or litter pick, the aforementioned amount becomes due and payable to the Seller at that time. If a puppy is part of the sale price the Buyer agrees to offer the same guarantees and conditions as in the contract for said canine.

Replacement Policy

Said canine will be replaced with another canine of equal or greater quality in exchange for said canine registration papers and a letter from a Veterinarian stating that the dog has been neutered, spayed, or euthanized. If said canine is to be euthanized the Seller must be notified in advance or this contract of guarantee will be considered void. The said canine will be replaced from the Seller's litters ASAP, with the Buyer paying all shipping and pick up costs.
